



Publication of SLAED Indicators Report 2018/19

The SLAED Indicators Report 2018/19 was published in January 2020. This is the seventh year that this report has been published and it continues to provide an overview of economic development delivery across Scotland's local authorities through a common reporting and measurement framework.

The annual report highlights the vital and lead role that local authorities play in economic development across Scotland, as well as how they enable and facilitate effective partnership working to achieve economic benefits and increase well being. The report gives insight into good practice, as well as opportunities for improvement, in local economic development.

The report highlights that in 2018/19 local authorities employed 1,300 FTE people in economic development, spending in the region of £555m on local economic development and tourism activities. They supported over 13,850 businesses, supported just over 15,300 unemployed people into jobs and levered in an additional £1.63 for every £1 of local authority funding spent on economic development projects.

 Publication of a SLAED Communications Plan setting out priorities, channels and a timetable of events and key outputs for year;

- Introduction of Working Groups on a range of horizontal themes (e.g.Community Wealth Building has already been established);
- Clear articulation of benefits of membership and what is needed from member councils in return;
- Reviewing sub group membership and identifying councils that may need support to better engage with the network;
- Timetable of meetings for the whole network (including the Annual Conference and AGM) around key themes e.g. climate change, public health, inclusive growth, child poverty etc;
- Report for the AGM on SLAED's achievements in the last year as well as priorities for the year ahead.

An initial update report on this work is available on the <u>SLAED Knowledge</u> <u>Hub</u> and a final report will be shared once final discussions have taken place with those councils that were unable to attend the workshops.

Offering a new stimulus for economic development policy development and new 'ways of working', the papers adopt an apolitical and inclusive ethos and seek to inject 'disruptive' thinking into a wider debate about Scotland's economy, with the aim of generating a better future for Scotland's citizens.

Papers will be published over the course of 2020 and the first 2 papers can be accessed on the <u>SLAED Knowledge Hub</u>. They cover the topics of statistics in Scotland and institutional reform, through the 'lens' of decarbonisation.

Regional Approaches to Maximising Inclusive Economic Growth: Local Authorities' Perspective



The experiences of Scotland's local authorities in relation to regional economic working have been set out in a new report. The work was undertaken by Ekos consultants and overseen by a Steering Group comprising the Improvement Service, COSLA, SOLACE and SLAED.

The <u>report</u> highlights councils' long history of engaging in cross-boundary working and emphasises the key role that local authorities play in supporting Scotland's economy. The feedback from councils confirmed that, whilst there was no appetite for structural change, there was a desire to explore how the positive impact of regional working could be maximised, including in relation to securing sustainable inclusive growth benefits.

The report concludes that councils now have an opportunity to lead and influence the next stages of regional economy working. The messages in the report are similar to those set out in Audit Scotland's report on Scotland's City Region and Growth Deals published in January, and a number of common issues are raised.

With respect to the suspension of the Scottish ESF programme, the Scottish Government has indicated, following strong representations from SLAED, COSLA and SOLACE, that it will resume payments on duly verified claims. This is good news but the suspension remains in place for the time being as work on developing a robust Unit Costs system is still in progress.



Infrastructure Commission Report

The Infrastructure Commission for Scotland has published its first report to the Scottish Government and recommended that future infrastructure decisions should be based on an inclusive net zero carbon economy. Business Booming in North Ayrshire's Circuit Enterprise Hub!

North Ayrshire's new incubation facility – The Circuit Enterprise Hub in Irvine – is almost at capacity, only seven months after opening.



The facility is for small local businesses who aspire to grow and take on their own premises within a 12 month period. It offers subsidised office accommodation for up to 16 new and ambitious early-stage growth businesses with access to on-site business support through the Council's Business Team who are also located in the new offices.

14 desks are now taken, with the remaining two set to go within the next few weeks. Businesses range from a social enterprise providing financial advice to those with disabilities, to a 'healthy meal prep' company.
